

# The 2026 Poland Spring x Grand Slam Yankees Ticket Sweeps Official Rules

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

## **Eligibility:**

The 2026 Poland Spring x Grand Slam Yankees Ticket Sweeps (the “Sweepstakes”) is open only to legal residents of New York, Connecticut, New Jersey, and Pennsylvania in select counties as outlined in the Appendix, who are at least eighteen (18) years old at the time of entry and who are members of the Rewards Drop® loyalty program. Participation constitutes each entrant’s full and unconditional agreement to these official rules (“Official Rules”). The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited. ## How to Enter:

### Method 1 – Redeem Drops:

Visit [www.rewardsdrop.com](http://www.rewardsdrop.com) and follow the links and instructions to login to your Rewards Drop account. If you are not a Rewards Drop member, follow the links and instructions to sign up. Once you are logged in, navigate to the Poland Spring catalog. Next, follow the links and instructions to select the Sweepstakes item within the catalog. Follow the links and instructions to redeem 25 Drops\* and you will receive 1 Sweepstakes entry into the Prize Pool drawing you selected.

### **Entry Limits:**

By traveling and attending the game, winner and guests voluntarily assume all risks related to exposure to COVID-19. **Odds of Winning:**

Seat locations at the game/event/exhibition and, unless otherwise stated in the applicable prize description, exact game/event/exhibition date shall be determined in the sole discretion of Sponsor. Each winner's guest(s) must be of legal age of majority in his/her(their) jurisdiction(s) of residence unless accompanied by a parent or legal guardian. Major League Baseball game/event/exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club and may be subject to change. The terms and conditions of the tickets awarded as part of any prize will govern in the event a legal game/event/exhibition, as defined by Major League Baseball, is not played or held due to weather conditions, an act of God, an act of terrorism, civil disturbance, or any other reason. Each winner and his/her guest(s) agree to comply with all applicable ballpark and venue regulations in connection with the prize; see [yankees.com/ballpark](http://yankees.com/ballpark) for details. Sponsor and the MLB Entities reserve the right to remove or to deny entry to any winner and/or his/her guest(s) who engage in a non-sportsmanlike or disruptive manner or with intent to annoy, abuse, threaten, or harass any other person at the game/event/exhibition. Released Parties (as defined below) will not be responsible for weather conditions; acts of God; acts of terrorism; civil disturbances; local, state, or federal regulation, order, or policy; work stoppage; epidemic, pandemic, or any other issue concerning public health or safety; or any other event outside of their control that may cause the cancellation or postponement of any Major League Baseball game/event/exhibition. Major League Baseball game/event/exhibition tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture and may invalidate the license granted by the game/event/exhibition ticket.

Prizes are non-transferable, and no substitution will be made except as provided in the Sponsor's sole discretion should the prize become unavailable. In this case, a prize of equal or greater value will be offered. Winners are responsible for all taxes and fees associated with prize receipt and/or use. ARVs are
